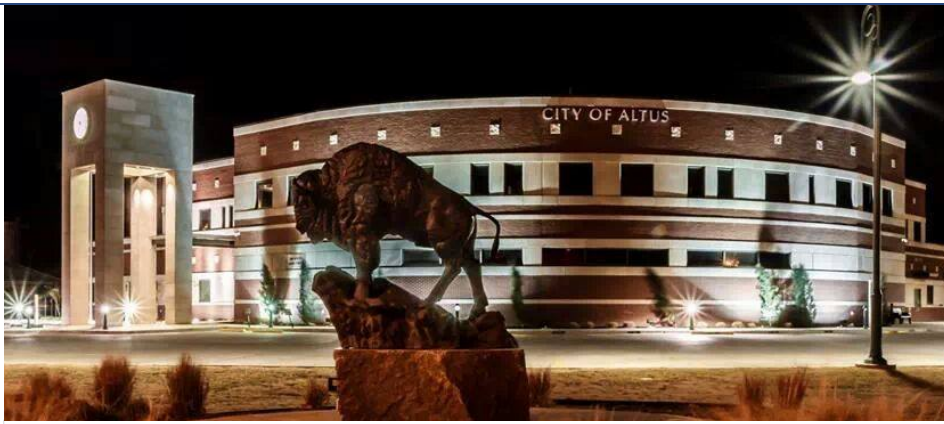

Pursuant to the National Environmental Policy Act (NEPA) and the National Historic Preservation Act (NHPA), EDA is conducting an environmental assessment of the potential of the proposed project to affect the environment and/or historic properties.

The project will construct a 22-acre detention pond (1600 x 600 feet), 3.5 feet deep, capable of holding 35.8 acre feet of water, designed to accommodate the 100-year storm event.
